



## **APPLYING FOR THE COURSE**

We meet everyone wishing to take the course. Submitting an application form does not commit you in any way, it simply reserves you a place on our interview list. Upon receipt of it we will contact you to arrange a meeting. Following its successful outcome your place is secured by deposit.

### **FEES.**

For student's committed to taking the course we aim to make the cost affordable. To that end we have a number of payment options which we think offer unrivalled flexibility and value. The fees include all training materials. For those students wishing to complete their Hypnotherapy Practitioner Diploma an £80 assessment and certification fee will be payable at the time of submission.

#### **Option One**

1. A non-refundable, non-transferrable deposit of £570.00
2. A single payment of £1,992.95 on or by the weekend of module one.
3. This represents a discount of almost £200 from the full price.
4. Making a total of £2,562.95 (inclusive of VAT)

#### **Option Two**

1. A non-refundable, non-transferrable deposit of £570.00
2. Three Stage payments - £730.73 at Modules 3 and 6 and £730.74 at Module 9
3. Making a total of £2,762.20 (inclusive of VAT)

#### **Option Three**

1. A non-refundable, non-transferrable deposit of £400.00
2. An initial payment of £170.40 followed by 13 monthly standing order payments of £168.60
3. Making a total of £2,762.20 (inclusive of VAT) payable over 14 months

### **REFUND POLICY.**

In the event of a student deciding not to continue with the course, the student will be entitled to a refund of 100% of that part of the training paid for but not received. Any training received but not paid for, will become payable.

### **QUALIFICATION**

The Diploma in Cognitive Hypnotherapy will be awarded to graduates who have successfully submitted their Hypnotherapy Practitioner Diploma coursework and had it assessed as being of an acceptable standard. The NLP Practitioner Certification will be awarded on the basis of ongoing assessment throughout the course and a multiple choice test.
